Mike Krapfl is a Special Agent in Charge in the Major Crimes Unit with the Iowa Division of Criminal Investigation, where he oversees agents working homicides, robberies, officer-involved shootings, and other felony offenses. Mike served as an agent in the Major Crimes Unit for 14 years and previously worked as a patrol officer and investigator for eight years with a municipal police department. Mike holds a Master's Degree in public policy and a BA in criminology from the University of Northern Iowa and instructed for 12 years as a member of the criminal justice faculty at the University of Dubuque. Mike is a member of the International Law Enforcement Educators and Trainers Association and presents at state and national law enforcement conferences.

After graduating from the University of Iowa College of Law, Jon Turbett began his law enforcement career as a Special Agent with the Iowa Division of Criminal Investigation assigned to the Gaming Unit. After five years, he was reassigned to the Major Crimes Unit, where he has worked since 2005. Jon currently investigates a significant number of felony level offenses, including homicides, human trafficking, fraud, and sex crimes. He has presented at the International Law Enforcement Educators and Trainers Association Conference, the Midwest Gang Investigators Conference, and the Conference on Crimes against Women. Jon oversees the legal component of The CTK Group's Interview and Interrogation courses.

Bill Grant attended Loras College in Dubuque and earned a Bachelor of Arts degree in Finance. In 1993, after briefly working in the business world, he joined the Dubuque County Sheriff's Office as a civilian employee collecting unpaid fines. Bill was a member of the Iowa National Guard, served on two overseas deployments in Africa and Iraq, and retired after serving from 1985 to 2008. While serving in the Iowa Guard, Bill was attached to the Dubuque Drug Task Force as an intelligence analyst and in 1996 became a Certified Peace Officer at the ILEA. While employed with Dubuque County, Bill has worked in the Civil, Jail, and Road Patrol Divisions and since 2013 has been assigned to the Criminal Investigation Division investigating general crimes.

**Class Topics:** CTK will discuss current national issues on interrogation, custody: an age-old battleground, voluntariness: 2025 battlegrounds, and the Molly Tibbetts Homicide case study.

Scam topics include recent trends and best practices for attempting to track funds and scammer origins. Other topics include useful resources, linking local investigations with other State and Federal Agencies, and preventative education for the public distribution.
